PART IV: SECURITY AND EMERGENCY SERVICES

If the event is cancelled, then a representative must call each department at least 24 hours before the event is expected to begin or the organization will be charged.

Legacy Events: Events with over two (2) years history in good standing

Major Events: Events with a sustained attendance of over 5,000 persons. These events require City Commission Approval.
