TITLE:	Motion Approving an Interlocal Agreement Between Broward County and the City of Fort Lauderdale for funding of the Demolition and Reconstruction of South Ocean Drive Bridge Utilizing Transportation Surtax Funding - (Commission District 4)

Recommendation

Staff recommends the City Commission approve an interlocal agreement between Broward County and the City of Fort Lauderdale, in substantially the form attached, for the surtax-funded municipal transportation project titled "Demolition and Reconstruction of South Ocean Drive Bridge," and authorize execution of the interlocal agreement.

Background

On January 21, 2021, the City Commission approved a Second Amendment to the Transportation Surtax interlocal agreement. By approving the Second Amendment, the City became eligible to receive funding for awarded transportation surtax projects by entering into project specific interlocal agreements with the County for each awarded surtax project.

This proposed interlocal agreement is for the "Demolition and Reconstruction of South Ocean Drive Bridge" project, which was awarded \$2,176,937 in surtax funding. This agreement will set the project schedule and deliverables, reporting requirements, and funding schedule that must be followed by the City. The City Attorney's Office cautions that the interlocal agreement provides for broad indemnification by the City in favor of the County and others under various circumstances.

The "Demolition and Reconstruction of South Ocean Drive Bridge" project will completely remove all existing bridge infrastructure and replace it with a new bridge structure. The new bridge structure shall be erected with new concrete piles, concrete bents, concrete bulkheads, and concrete wing walls. The new bridge shall be about 1.5' higher than the existing bridge. The project will be entirely funded through the awarded Surtax funds excluding utility work and staff project management expenses which will be identified by

CAM 21-0754 Exhibit 4 Page 1 of 3 the City. With the execution of the proposed interlocal agreement, the Public Works Department anticipates starting construction by the end of 2021.

Resource Impact

There is a positive fiscal impact in the amount of \$2,176,937 associated with this item, contingent upon the appropriation approval of the Consolidated Budget Amendment CAM 21-0096.
