TITLE: Resolution Approving an Interlocal Agreement Between Broward County

and City of Fort Lauderdale for Funding of the Demolition and Reconstruction of South Ocean Drive Bridge Utilizing Transportation Surtax

Funding - (Commission District 4)

Recommendation

Staff recommends the City Commission adopt a resolution approving an Interlocal Agreement between Broward County and City of Fort Lauderdale for Surtax-Funded Municipal Transportation Project: Demolition and Reconstruction of South Ocean Drive Bridge (P12087) in substantially the form attached to City Commission Agenda Memo 21-0566, and authorizing the Mayor and the City Manager to execute the Interlocal Agreement.

Background

On July 6, 2021, via Resolution 21-128, the City Commission approved an Interlocal Agreement between Broward County and City of Fort Lauderdale for the South Ocean Bridge Project (Exhibit 1 and 3). The Surtax-Funded Municipal Transportation Project (P12087) will be for the demolition and reconstruction of South Ocean Drive Bridge (Exhibit 2). The previous approved Interlocal Agreement contemplates a resolution authorizing execution of the Interlocal Agreement as presented in exhibit 5.

Resource Impact

There is no fiscal impact associated with this action. The funding for this project in the amount of \$2,176,937 was approved at the July 6, 2021, City Commission Meeting (Exhibit 4) and Consolidated Budget Amendment 21-0096.
