TITLE: Motion Approving a Five-year Agreement for Promotion of Downtown

Countdown New Year's Eve Celebration with O.B. Festival Events, LLC -

(Commission District 2)

Recommendation

Staff recommends the City Commission approve a motion for a Five-year agreement for promotion of Downtown Countdown New Year's Eve celebration with O.B. Festival Events, LLC, in substantially the attached form.

Background

The City of Fort Lauderdale annually organizes and operates the "Downtown Countdown" New Year's Eve Celebration that takes place in downtown Fort Lauderdale, on December 31st/January 1st of each year.

For the past five years, the City has held an agreement with OB Events which is whollyowned by The Orange Bowl Committee, Inc. O.B. Festival Events, LLC. The partnership has been very positive with OB Events and therefore staff recommends approval of another five-year contract.

Pursuant to Section 2-189(c), Code of Ordinances of the City of Fort Lauderdale, the City Manager has determined that the services offered by OB Events are proprietary in nature and that it would be in the best interest of the City to not utilize competitive bids to purchase these services, but instead, the price and scope of services will be negotiated.

OB Events role will include marketing the event in all of their Orange Bowl Festival marketing and promotions and the securing of sponsorships to aid in the funding of the event.

The City will be responsible for all aspects of event production, staging, entertainment, management, security and operation, including, but not limited to, operations, tickets, concessions, grandstands, barricading, police, and business administration if the Event takes place. The City grants O.B. Events a limited, non-assignable, nonexclusive license

to use the City's trade name and other marks solely for the purposes of performing its responsibilities under the agreement and promotion of the event.

For sponsors signed/recruited by O.B. Events, net revenues shall be paid fifty percent (50%) to the City and fifty percent (50%) to O.B. Events.

The Orange Bowl Committee has been a great partner with the City for not only this event but also provided \$1.5 million dollars toward the improvements to the football field and new running track at Carter Park.

Resource Impact

There is no fiscal impact associated with this item.
