A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA, ADOPTING THE TENTATIVE BUDGET OF \$141,730 FOR THE SUNRISE KEY NEIGHBORHOOD IMPROVEMENT DISTRICT FOR FISCAL YEAR BEGINNING OCTOBER 1, 2021 AND ENDING SEPTEMBER 30, 2022.

WHEREAS, pursuant to applicable provisions of law, the City Commission has prepared a tentative budget for the Sunrise Key Neighborhood Improvement District for the fiscal year beginning October 1, 2021 and ending September 30, 2022; and

WHEREAS, a "Notice of Proposed Millage Rate and Tentative Budget Hearings" has been published as required in Section 200.065, Florida Statutes, advising the public that a public hearing on the proposed millage rate and tentative budget would be held on September 8, 2021 at 5:01 P.M., or as soon thereafter as possible, in the City Commission Chambers at City Hall, 100 North Andrews Avenue, Fort Lauderdale, Florida; and

WHEREAS, said public hearing has been held as stated above and comments from the public concerning said proposed millage rate and tentative budget have been heard and considered; and

WHEREAS, as set forth during the tentative budget hearing, the appropriations and revenue estimate for the Budget for the Sunrise Key Neighborhood Improvement District fiscal year starting October 1, 2021 and ending September 30, 2022 is in the amount of \$141,730; and

WHEREAS, it is the desire of the City Commission of the City of Fort Lauderdale to adopt a tentative budget for the Sunrise Key Neighborhood Improvement District for the fiscal year beginning October 1, 2021 and ending September 30, 2022;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the tentative budget attached and incorporated herein as Exhibit A is hereby adopted and approved as the tentative budget of the Sunrise Key Neighborhood Improvement District for the fiscal period beginning October 1, 2021 and ending September 30, 2022.

MINUTES SUNRISE KEY NEIGHBORHOOD IMPROVEMENT DISTRICT June 23, 2021

Ray Parker called the Zoom meeting to order at 1:05 p.m. Directors also present at the meeting were Richard Campillo, Cliff Berry, Tom Walter, Milton Jones, and Mark Grant. Caldwell Cooper was not in attendance. Also present at the meeting were the individuals listed on the sheet attached to these minutes. Ray Parker determined a quorum of Directors was present.

Mark Grant announced that he would make certain the City was made aware that Ray Parker and not Cliff Berry was President.

Ray Parker asked that minutes of the meeting of February 20, 2021 be approved. Mark Grant asked that the reading of the minutes be waived since all directors had previously received the minutes. Upon motion duly made and seconded, the minutes were approved as presented.

Ray Parker and Mark Grant discussed the proposed budget for 2022. During the budget discussion, Ray Parker discussed the decorative street signs. It was also agreed that the hourly rate for the officers be increased from \$45.00 to \$48.00 effective July 1, 2021 but the increased hours do not take effect until January 1, 2022. The landscape budgeted amount was increased by \$8,000.00 to cover the cost to improve the swale area on Sunrise Key Boulevard.

After a full discussion, Ray Parker made a motion that the budget for 2022 be set at \$137,000.00 and that the millage rate for 2022 be set at 1.0 mil. Such motion was seconded and after further discussion, the motion was unanimously approved. The following is the approved budget:
