TITLE: Second Reading - Ordinance Repealing Article IV of Chapter 19, Relating
to Lockhart and Fort Lauderdale Stadiums - **(Commission District 1)**

Recommendation

Staff recommends the City Commission approve an ordinance, on second reading, repealing Article IV of Chapter 19, of the Code of Ordinances of the City of Fort Lauderdale relating to Lockhart and Fort Lauderdale Stadiums.

Background

On July 18, 2019, the City of Fort Lauderdale entered into a Comprehensive Agreement with Miami Beckham United, LLC to design, construct, occupy, manage and maintain portions of the property described as Parcels 19B, 25, 26, and 27 located at the Fort Lauderdale Executive Airport in the City of Fort Lauderdale, commonly known as the site of the former Lockhart and Fort Lauderdale Stadiums. Miami Beckham United, LLC has constructed a new state-of-the-art stadium currently known as the "DRV Pink Stadium", and a new training facility, both used, managed, and operated by the MLS professional soccer team, Inter Miami CF. The initial term of the agreement is due to expire on December 21, 2069. Since the Lockhart and Fort Lauderdale Stadiums no longer exist, Article IV of Chapter 19, of the Fort Lauderdale Code of Ordinances, serves no purpose and should therefore be repealed in its entirety.
