

**AMENDMENT TO AGREEMENT

**THIS AMENDMENT TO AGREEMENT**, made this \_\_\_\_ day of \_\_\_\_\_ 2021, by and between the City of Fort Lauderdale, a Florida municipality, ("City"), whose address is 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016, and Infor (US) LLC, a Delaware limited liability company authorized to transact business in the State of Florida, ("Contractor") whose address and phone number are 4111 East 37<sup>th</sup> Street North, Wichita, Kansas 67220, Phone: 813-334-3071, Email: [helen.dawson@infor.com](mailto:helen.dawson@infor.com).

WHEREAS, the City and Ciber, Inc., a Delaware corporation authorized to transact business in the State of Florida, ("Assignor"), entered into an Agreement for Professional Services RFP 742-11378 Enterprise Resource Planning (ERP) System Solution dated October 31, 2016, (the "Contract"); and

WHEREAS, pursuant to an Asset Purchase Agreement, the Assignor has irrevocably granted, sold, transferred, conveyed, assigned, and delivered, as applicable, the Contract to Infor dated June 6, 2017, and

WHEREAS, the City and Contractor wish to amend the Agreement by adding six (6) years to the initial term of the Agreement;

NOW THEREFORE, for and in consideration of the mutual promises and covenants set forth herein and other good and valuable consideration, the City and the Contractor agree to amend the Agreement as follows:

1. Section III AGREEMENT TERM of the Agreement is hereby amended to add the following: The initial contract period shall commence on **October 31, 2016 and shall end on October 30, 2032. The City and the Contractor may each extend the Agreement for two (2) additional one (1)-year terms (for an aggregate of two (2) additional years after the Initial Contract Term)** providing all terms conditions and specifications remain the same.
2. All other terms and provisions of the original Agreement between the Parties shall remain in full force and effect.
