

AMENDMENT ONE TO FLEX SERVICES AGREEMENT

This Amendment One ("Amendment One") to the Flex Services Agreement dated July 13, 2020 (the "Agreement") between ShotSpotter, Inc. ("ShotSpotter") and the City of Fort Lauderdale ("Customer" or "City") is effective as of the last date of signature below. Except as amended herein, all other terms and conditions of the Agreement shall remain in full force and effect. In the event of a conflict between the terms of the Agreement and this Amendment One, the terms of this Amendment One shall control.

WHEREAS, Customer desires to expand its existing ShotSpotter Respond (formerly Flex) Services Coverage Area; and

WHEREAS, ShotSpotter has proposed a 0.66 square mile expansion of the Customer's Coverage Area.

The Parties agree as follows:

1. ShotSpotter will implement a 0.66 square mile expansion of the Customer's Coverage Area as set forth in ShotSpotter's proposal ID FTLFL072821 attached hereto as Exhibit A.
2. As further defined in Exhibit A, in consideration of a two-year commitment for the subscription service for such expansion, ShotSpotter will waive the one-time service start-up fees.
3. Fees will be due for Year 1 and Year 2 of the 0.66 sq. mi. expansion as set forth in Exhibit A.

EACH PARTY'S ACCEPTANCE HEREOF IS EXPRESSLY LIMITED TO THE TERMS OF THIS AMENDMENT ONE AND NO DIFFERENT OR ADDITIONAL TERMS CONTAINED IN ANY CONFIRMATION, PURCHASE ORDER, OR OTHER BUSINESS FORM, WRITING OR MATERIAL SHALL HAVE ANY FORCE OR EFFECT UNLESS EXPRESSLY AGREED TO IN WRITING BY THE PARTIES.

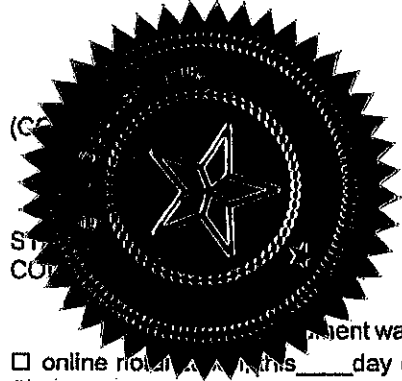

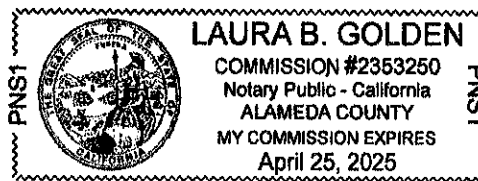
