NOTICE OF FUNDING AVAILABILITY (NOFA) STATE HOUSING INITIATIVES PARTNERSHIP (SHIP) FUNDS PROGRAM YEAR (PY) 2021-2022

PLEASE TAKE NOTICE that the City of Fort Lauderdale has received \$1,251,351.00 of SHIP funds for PY 2021-2022. These funds must be used in accordance with 2019-2022 approved Local Housing Assistance Plan (LHAP). Florida Administrative Code 67-37.005 requires that SHIP funds be advertised at least 30 days prior to taking applications, unless funds are not available due to a waiting list. The City will establish a waiting list if there are eligible applicants for strategies where the funding has been exhausted. Applications for each strategy will be processed on a first qualified, first served basis.

The City Commission of the City of Fort Lauderdale, Florida, will hold a Public Meeting on Tuesday, October 5, 2021, at 6:00 P.M., or as soon as possible thereafter, in the City Commission Chambers, City Hall, 100 North Andrews Avenue, Fort Lauderdale, Florida 33301, for the purpose of hearing any objections or comments which might be made to the proposed use of the SHIP funds as described below.

The City proposes to use the SHIP funds for the following strategies:

 Administration
 \$125,135.10

 Special Needs
 \$250,270.20

 New Construction-Ownership
 \$700,000.00

 Owner Occupied Rehabilitation
 \$125,945.70

 Project Delivery
 \$50,000.00

Project and activities will be prioritized based on the following criteria, unless otherwise stated. A focused use of SHIP funds will be made to assist:

- Applicants in the target area east of I-95 and West of Northwest 9th Avenue, South of Sunrise Boulevard and North Of Broward Boulevard.
- Elderly and special needs persons.
- Development of new affordable housing and the preservation of existing affordable rental housing throughout the City.
