The AHAC's Report will evaluate the implementation of Affordable Housing Incentives in the following areas: a. The processing and approval of development orders or permits, as defined in Florida Statutes, Sections 163.3164(7) and (8), for affordable housing projects is expedited to a greater degree than other projects.

 b. The modification of impact-fee requirements, including reduction or waiver of fees, and alternative methods of fee payment for affordable housing.

 c. The allowance of flexibility in densities for affordable housing.

 d. The reservation of infrastructure capacity for housing for very-low-income persons low-income persons and moderate-

The allowance of flexible lot configurations, including zero-lot-line configurations for affordable housing. h. The modification of street requirements for affordable housing. i. The establishment of a process by which a local government considers. before adoption, policies, procedures, ordinances, regulations, or plan provisions that increase the cost of housing. The preparation of a printed inventory of locally owned public lands suitable for affordable housing. k. The support of development near transportation hubs and major employment centers and mixed-use developments.

Other Affordable Housing Incentives will also be discussed.
