Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the Edgewood Neighborhood Stormwater Improvements Project (Project), with David Mancini & Sons, Inc., in the amount of \$14,471,533.

Background

The Edgewood Neighborhood experiences flooding negatively impacting properties and businesses. This Project provides both new stormwater infrastructure and repairs to existing stormwater infrastructure within the Edgewood Neighborhood to address recurring flooding throughout the neighborhood. The Project aims to improve stormwater runoff collection and conveyance. The Project also includes the resurfacing of roads and restoration of landscaping impacted by the construction activities.

On June 4, 2021, the Procurement Services Division issued Invitation to Bid No.12545-613. On July 27, 2021, the City opened the seven (7) bids received in response to the solicitation and reviewed for compliance with the solicitation specifications. David Mancini & Sons, Inc. was deemed the lowest cost, responsive and responsible bidder. None of the seven (7) vendors that responded have claimed status as a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise.

Resource Impact

There will be a fiscal impact to the City in the amount of \$14,471,533 for the construction contract award with allowances included and \$814,320 for estimated in-house project management fees for a total cost of \$15,285,853. Funds for this contract in the total amount of \$15,285,853 are available in the FY2022 Community Investment Plan in the account listed below.
