TITLE: Resolution Approving the Transfer of Seven (7) City-Owned Properties

Located in the Northwest-Progresso-Flagler Heights and Central City Community Redevelopment Area to the Fort Lauderdale Community Redevelopment Agency for Affordable Housing, Pursuant to Section 8.02 of the Charter of the City of Fort Lauderdale - (**Commission Districts 2**

and 3)

Recommendation

Staff recommends the City Commission approve a transfer of seven (7) City-owned properties located in the Northwest-Progresso-Flagler Heights and Central City Community Redevelopment Area to the Fort Lauderdale Community Redevelopment Agency ("CRA") for affordable housing, pursuant to section 8.02 of the Charter of the City of Fort Lauderdale.

Background

On May 18, 2021, the City Commission adopted Resolution No. 21-98 (Exhibit 1) that designated eight (8) surplus properties for affordable housing as required by Florida Statute 166.0451. This item involves the conveyance of those eight (8) properties to the Fort Lauderdale CRA that are all located within the Northwest-Progresso-Flagler Heights and Central City Community Redevelopment Area (Exhibit 2). On August 17, 2021, the City Commission adopted Resolution 21-158 (Exhibit 3) declaring its intent to convey eight (8) City-owned properties to the CRA. The properties being conveyed are zoned for residential use and range from 5,000 to 8,781 square feet (Exhibit 4). The properties will be conveyed to the CRA subject to a covenant restricting occupancy of the property to households that meet the income and other guidelines of Section 420.0004(3) of the Florida Statutes. The CRA will use a Request for Proposal process for affordable housing bids.

The property located at 611 NW 14th Terrace is not an eligible property and has been removed. Staff request a transfer of only seven (7) properties to the Fort Lauderdale Community Redevelopment Agency.
