TITLE:	Motion Accepting a Donation of a Britto Statue for Hardy Park from Yasmine Reger in the Amount of \$116,050.00 - (Commission District 4)

### **Recommendation**

Staff recommends the City Commission approve a motion authorizing the City Manager to accept a donation of a Britto Statue to be placed at Hardy Park along SW 7 Street and to execute any documents required between Yasmine Reger and the City of Fort Lauderdale to accept the Britto Statue donation.

#### **Background**

Tarpon River resident, Yasmine Reger, wishes to donate a sculpture by renowned artist, Romero Britto, to the City of Fort Lauderdale. The Board of Directors of the Tarpon River Civic Association supports the donation and, together with Mrs. Reger, have expressed a preference for the statue to remain in the Tarpon River neighborhood and selected Hardy Park as the ideal location. The statue will be in close proximity to the Southside Cultural Arts Center and will be visible to passing traffic.

On August 30, 2021, the Britto Statue was presented to the Public Art and Placement Advisory Board. A motion was unanimously passed 6 to 0 in favor of the artwork being placed at the Hardy Park location, per the wishes of the owner making the donation (see Exhibit 2). A contractor will relocate the statue from the donor's property to Hardy Park. The fee to re-locate the statue is estimated at \$15,000.

The original receipt for the purchase of the statue is included as Exhibit 4. It was originally purchased for \$116,050.

#### Resource Impact

There is an estimated cost of \$15,000 to relocate the statue. Funds for this purchase in the amount of \$15,000 are available in the FY 2022 Budget in the account listed below:
