A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DENYING THE APPLICATION BY STEPHEN C. FARRELL, FOR A WAIVER OF LIMITATIONS FOR THE INSTALLATION ONE (1) 24,000 POUND FOUR (4) POST BOAT LIFT EXTENDING A MAXIMUM DISTANCE OF +/- 40' FROM THE WATER SIDE PROPERTY LINE INTO THE INTRACOASTAL WATERWAY PURSUANT TO SECTION 47-19.3(c) AND (d) OF THE CITY OF FORT LAUDERDALE UNIFIED LAND DEVELOPMENT REGULATIONS ("ULDR"), FOR PROPERTY LOCATED AT 435 BAYSHORE DRIVE, UNIT# 402, FORT LAUDERDALE, FLORIDA 33304.

WHEREAS, Section 47-19.3(e) of the City of Fort Lauderdale, Florida Unified Land Development Regulations (hereinafter "ULDR") provides that the City Commission may waive the limitations of Section 47-19.3(c) and (d), under extraordinary circumstances; and

WHEREAS, Stephen C. Farrell (hereinafter "Applicant") owns the Property located at 435 Bayshore Drive, Unit# 402, Fort Lauderdale, Florida, 33304, Property ID# 5042 01 CF 0060 (hereinafter "Property"); and

WHEREAS, Applicant submitted an application for a Waiver of Limitations to allow the installation of one (1) 24,000 lb. four (4) post boat lift extending a maximum distance of +/- 40' from the water side property line into the Intracoastal Waterway (hereinafter "Application");

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:
