

Fire Rescue also charges 45 minutes to ser up and 45 minutes to break down for each event. If the event is cancelled, then a representative representative must call each department at least 24 hours before the event is expected to begin or the organization will be charged.

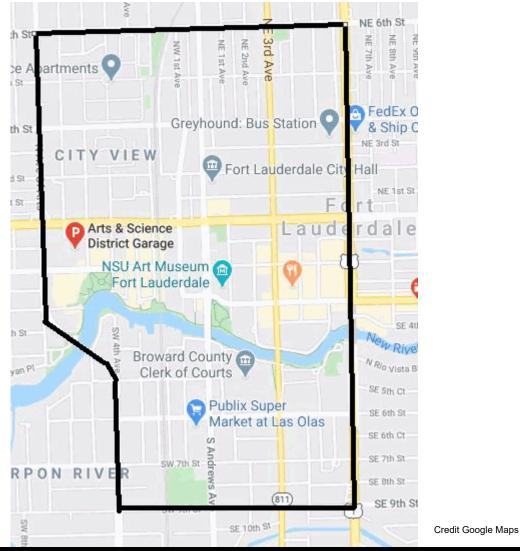

The Police will review the plan and inform you if it meets City Requirements.

If a Fort Lauderdale Police vehicle is required then a Hold-Harmless Agreement must be signed and Liability coverage of a minimum of one million dollars (\$1,000,000) must be provided.

Legacy Events: Events with over two (2) years history in good standing

Major Events: Events with a sustainewd attendance of over 5,000 persons. These events require City Commission Approval.
