Post Boat Lift - (Commission District 2)

Recommendation

Staff recommends the City Commission adopt a resolution granting a Waiver of Limitations, pursuant to Unified Land Development Regulations ("ULDR") Section 19.3 (e), for the installation of one boat lift located at 435 Bayshore Drive #402, Fort Lauderdale, Florida 33304 / Slip#6.

Background

The applicant is seeking a resolution, pursuant to ULDR Sec. 47-19.3 (e), granting a Waiver of Limitations, pursuant to ULDR 47-19.3(e) granting a Waiver of Limitations (a waiver to allow mooring structures to extend beyond the maximum distance as defined by City Code) of Section 47-19.3(c) and (d) of the Unified Land Development Regulations (ULDR) for the installation of one 24,000 pound four-post boat lift extending a maximum of +/-40 feet from the property line into the Intracoastal Waterway (ICWW).

The applicant's Summary Description specifies that the proposed boat lift is necessary to safely moor the resident's vessel during high wind events, severe weather, and within the adjacent boat traffic (property not located in 'No Wake' zone).

It should be noted that this application is for a second boat lift within 100-feet of a preexisting boat lift on the property. The application has received a Site Plan Level II review as of September 29, 2021, subject to Commission "call-up" which shall expire October 29, 2021.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$1500. is required.

The Marine Advisory Board recommended unanimous approval of the application 12 to 0 at the September 2, 2021 meeting (see Exhibit 3).

Resource Impact

There is a positive fiscal impact in the amount of \$1,500. Revenue related to the application fee is included in the FY2022 Operating Budget in the account listed below.
