A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPOINTING ROBERT J. NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That Robert J. Bigge, Jr., of the law firm of Bigge & Rodriguez, P.A., is retained as special counsel to the City of Fort Lauderdale, Florida in connection with bankruptcy proceedings filed by Riverfront Cruise and Anticipation Yacht Charters, LLC and any related adversarial action(s).

<u>SECTION 2</u>. That the City Commission of the City of Fort Lauderdale, Florida, authorizes the City Attorney to execute an agreement with Bigge & Rodriguez, P.A., with terms acceptable to the City Attorney, to implement this Resolution.

<u>SECTION 3</u>. That the hourly rate of \$450.00, plus actual reasonable expenses, subject to the City Attorney's approval, are prescribed as the compensation to be paid to Bigge & Rodriguez, P.A.
