On April 22, 2021, the Broward County Planning Council took the action listed below pertaining to the City of Fort Lauderdale's request for recertification of its Future Land Use Element.

The Planning Council "provisionally" recertified the City's Future Land Use Element, effective April 22, 2021, as follows:

• Text amendment for local Ordinance Number C-20-05.
