NOW, THEREFORE, in consideration of the mutual obligations set forth herein, the Parties agree to the following:

- 1. This Amendment One shall be effective on the date above written.
- 2. The Term shall be extended to November 30, 2022 and shall run coterminous with Agreement No. 5500002978, as amended, between Contractor and Santa Clara.
- 3. All other terms and conditions of the agreement, except as amended herein shall remain unchanged and in full force and effect.
