TITLE:	Resolution Authorizing the City Manager to Execute an Amendment to the Motorized Watercraft Concession Agreement with Atlantic Beach Clubs- Two, Inc, to Defer Rent Payments for a Period of Three Months from October 2021 through and including December 2021 - ( <b>Commission District 2</b> )

# **Recommendation**

Staff recommends the City Commission adopt a resolution authorizing the City Manager to execute an amendment to the Motorized Watercraft Concession Agreement with Atlantic Beach Clubs-Two, Inc., in substantially the attached form, to defer rent payments for a three-month period from October 2021 through and including December 2021. The amount of rent deferred will be paid to the City over a period of three months commencing in January 2022 and ending in March 2022.

## Background

The Covid-19 pandemic crisis has adversely affected our community and the City of Fort Lauderdale is sensitive to the stress and financial impact the pandemic has had on our local businesses. Throughout the pandemic, certain businesses have experienced increase in traffic while others have not due to shutdowns, resurgences of the COVID-19 virus and supply chain challenges related to the virus.

On May 19, 2020, the City Commission authorized the City Manager to amend certain tenant leases to defer rental payments for a period of three (3) months to assist its tenants by assuring the longevity of their business and the security of their contractual obligations.

On November 4, 2021, the Procurement Department received the letter attached as Exhibit 2, from David Heemskerk, Owner of Atlantic Beach Clubs II, requesting to defer its rent.

Staff recommends offering a three (3) month rent deferment for the City's Motorized Watercraft concessionaire to assist with the challenges arising from the virus to the business. The proposed rent deferment totals approximately \$24,900. At the end of the deferral period, the concessionaire will begin making its normal monthly payments in

addition to its deferred rental payments for a period of three (3) months commencing in January 2022 and ending in March 2022.

The delegated authority will allow the City Manager to ament the lease agreement for a three (3) month period rent deferment without extending the terms of the lease.

## Resource Impact

This action will not have a negative impact to the City in Fiscal Year 2022 if all rent revenue is collected by March 2022.
