TITLE: Resolution Supporting Broward County Traffic Engineering Division to
Retain “NO THRU TRUCKS” Signage and Install “AREA SPEED LIMIT”
Signage on the Eastbound Lane of NE 49th Street at Bayview Drive -
(Commission District 1)

Recommendation

Staff recommends the City Commission adopt a Resolution supporting the Broward County Traffic Engineering Division (BCTED) to retain a “NO THRU TRUCKS” sign on the SE corner of the intersection of NE 49th Street and Bayview Drive and install an “AREA SPEED LIMIT” sign.

Background

Transportation and Mobility staff received notification from the Fort Lauderdale Police Department that the “AREA SPEED LIMIT” sign on NE 49th Street, east of Bayview Drive was missing. Upon a field visit by BCTED staff, the sign was confirmed missing. In determining the placement of the sign, BCTED staff determined that the most appropriate location for an “AREA SPEED LIMIT” sign would be on the same post as the existing “NO THRU TRUCKS” sign on the SE corner of the intersection of NE 49th Street and Bayview Drive.

BCTED had no record of a previous resolution approving the “NO THRU TRUCKS” sign at the described location and is requesting a resolution for the existing sign and to install and maintain the “AREA SPEED LIMIT” sign on the same post.

Broward County requires the City Commission to approve a Resolution of Support for the installation and maintenance of traffic signage. Transportation and Mobility staff recommends retaining the “NO THRU TRUCKS” signage and installing the “AREA SPEED LIMIT” signage on the SE corner of the intersection of NE 49th Street and Bayview Drive for the purpose of enhancing public safety in that residential area.

Resource Impact

There is no fiscal impact associated with this action.
