TITLE: Motion Authorizing the Execution of two Sovereignty Submerged Lands

Easements with the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida – South Redundant Sewer Force Main –

(Commission District 4)

Recommendation

Staff recommends City Commission approve the execution of two Sovereignty Submerged Lands Easements with the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida (State of Florida) for the purposes of acquiring the use of sovereignty lands solely for the installation of a subaqueous sewer force main crossing off the Tarpon River and New River along SE 9th Ave.

Background

After numerous breaks to the City's primary sewer force main in December 2019, the City published a competitive solicitation titled "Emergency Procurement Proposal No. 12367-496 Design/Build Installation of New Redundant Bypass Line" to install new force main from Station B-Repump to George T. Lohmeyer Regional Wastewater Treatment Plant on December 23, 2019, Due to the emergency nature of this project FDEP permits were issued for the construction of the New Redundant Bypass under Tarpon River (FDEP Permit No. 06-383951-001-EI, attached as Exhibit 1) and New River (FDEP Permit No. 06-384624-001-EI, attached as Exhibit 2). As a condition of this permit two Sovereignty Submerged Lands Easements are required.

The proposed Sovereignty Submerged Lands Easements with the State of Florida are necessary for the maintenance of the section of force main across the Tarpon River and New River. Attached as Exhibits 3 and 4 are the Tarpon River and New River Sovereignty Submerged Lands Easements from the State of Florida, respectively.

Resource Impact

There is no fiscal impact to the City associated with this item.
