

**FIRST AMENDMENT TO INTERLOCAL AGREEMENT**

THIS FIRST AMENDMENT TO INTERLOCAL AGREEMENT, effective as of \_\_\_\_\_ 2026, is made and entered into by and between the City of Fort Lauderdale, Florida, a municipal corporation (hereinafter referred to as “CITY” or “the CITY”) and the Fort Lauderdale Community Redevelopment Agency, a special district created pursuant to Chapter 163, Part III, Florida Statutes, (hereinafter referred to as “CRA”).

**RECITALS**

WHEREAS, the City and the CRA entered into that Interlocal Agreement dated August 29, 2024; and

WHEREAS, the parties desire to add additional projects to the Agreement; and

WHEREAS, CRA is willing to provide funding from its Trust Fund to accomplish certain mutually beneficial goals and objectives, in accordance with the terms and conditions set forth in this Agreement; and

WHEREAS, the CRA Board of Commissioners finds that the proposed project described herein comply with the Central City Redevelopment Plan; and

WHEREAS, the Board of Commissioners of the City finds that the proposed project constitute a public purpose.

NOW, THEREFORE, in consideration of the mutual promises and conditions contained in this Agreement and other good and valuable consideration, the receipt of which is acknowledged, CITY and CRA agree as follows:

**TERMS**

1. The recitals are true and correct and incorporated herein.
2. The Project described in Exhibit “B” is hereby added to this Agreement.
3. In all other respects, the Interlocal Agreement remains in full force and effect as amended.
