RE: Public Participation Meeting Summary for the land use plan amendment and rezoning for warehouse distribution logistics center known as Central Broward Logistics (DRC Case No. UDP-L24003 and UDP-Z24009)

Dear Ms. Tappen:

Pursuant to City's Unified Land Development Regulations, the Applicant held a public participation meeting to present the plans for a proposed warehouse distribution logistics center. The public participation meeting was held in-person at the Rock Island Elementary School Cafeteria on Thursday, October 16, 2025 at 6:00 pm. This is in addition to a community meeting held on March 13, 2025 at Bass Park. The meeting on October 16, 2025 was noticed via mail to all property owners within 300' of the Project, notifying the property owner of the date, time, and location of the public participation meeting. Notice was also sent to Sharon Alexander, President of the Golden Heights Homeowners Association the only city-recognized civic association within 300' of the Project, and courtesy notice was sent via e-mail and mail to Linda Patrick, President of the Lake Aire Civic Association.

Approximately twenty-seven (27) people attended the public participation meeting. A copy of the sign in sheet is included with this letter. The presentation started at 6:12 pm and was conducted by Robert Lochrie, attorney for Prologis, who is under contract to purchase the subject property from the current owner. A PowerPoint presentation was presented to the attendees, which illustrated the proposed development plan. Mr. Lochrie introduced the representatives from Prologis, the developer and Langan Engineering, the firm handling the environmental and civil engineering for the site. Mr. Lochrie explained the proposed warehouse distribution logistics center and the change of the land use and zoning from residential to commercial. Following the presentation, time was allotted for questions and comments. After addressing all questions from attendees, the Applicant concluded the meeting around 7:15 pm.

Residents asked questions about the drainage from the neighborhood to the existing lake. The engineer for the project, Michael Carr explained that there are 3 outfalls from the neighborhood into the existing lake and those will be maintained in the proposed plan. The applicant agreed to look into additional areas within the area which neighbors indicate have drainage issues. One resident indicated that the area is a food desert and would like to have something that the neighborhood needs. Some residents discussed historical health issues of the neighborhood which they attribute to the environmental contamination caused by the Wingate site next to the subject property. The applicant's environmental engineer explained that the contamination is on the bottom of the lake (lake sediments). The current owner was issued permits to fill in the lake and this is a remediation plan that was approved by the environmental agencies. The applicant offered to share this information, if requested. Some residents asked how the project would benefit the community. The applicant explained that the plan includes remediating the environmental contamination in the lake by capping the sediments at the bottom of the lake. In addition, the applicant explained that the new development plan includes a large retention lake area which will enable most of the homes to continue to have lake views. The applicant concluded the

meeting by stating that it would make itself available for follow-up meetings with the community in larger or smaller groups if requested.

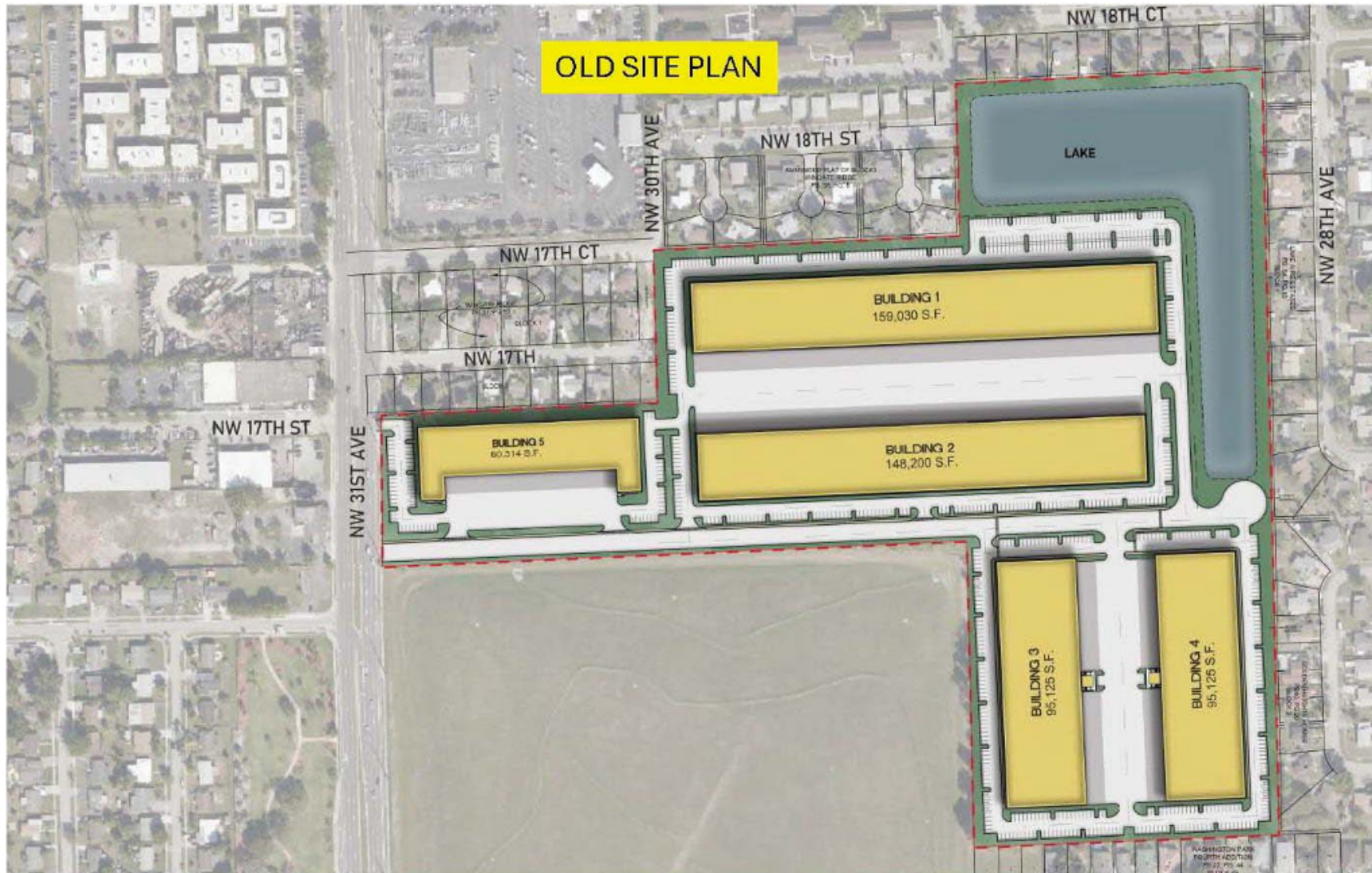

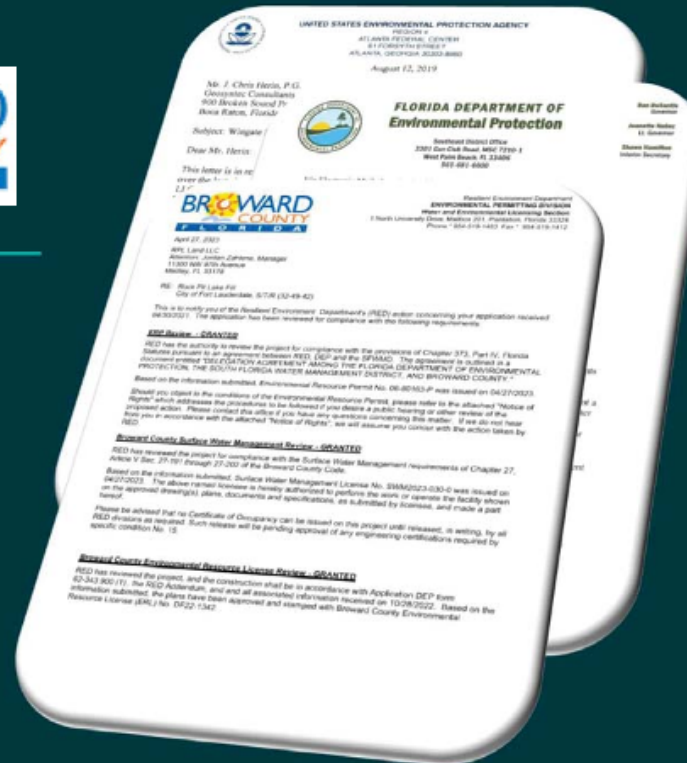

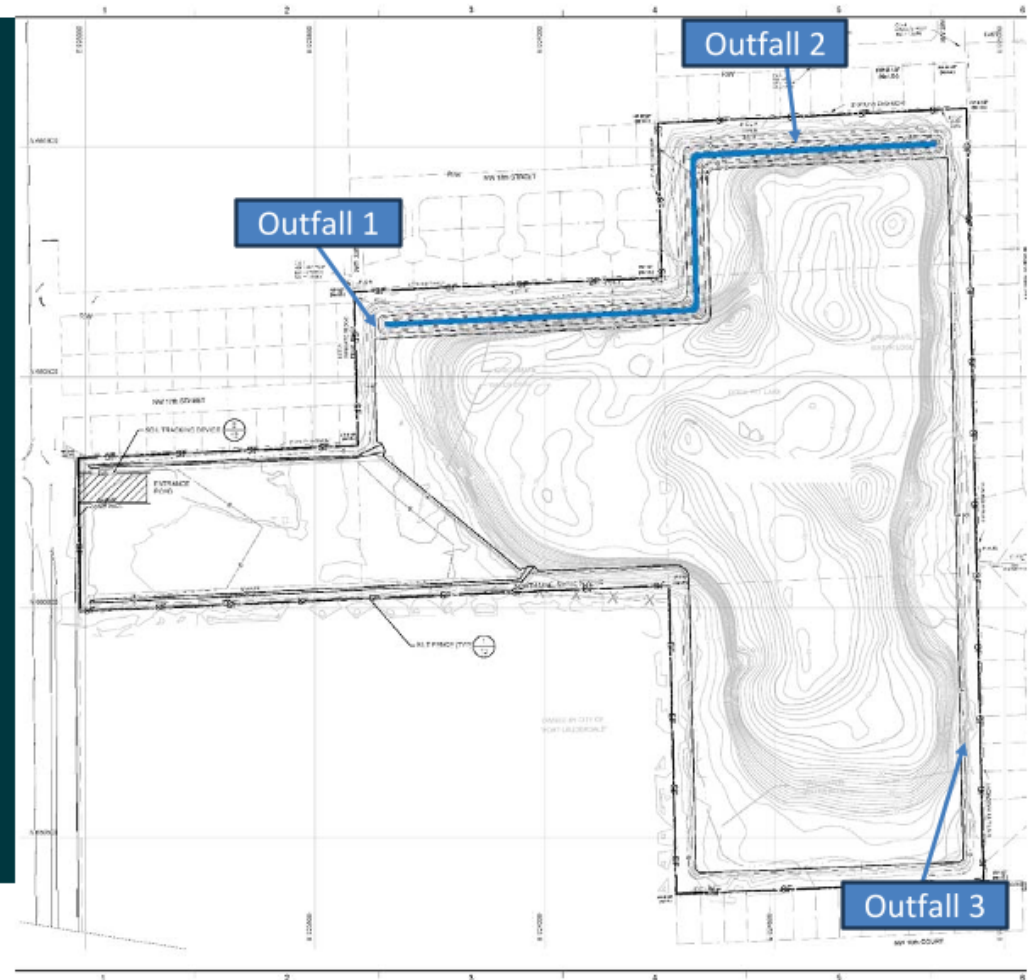
Current Lake Fill Permit Approval and Modification

Approvals:

From USEPA, FDEP and Broward County EPD Requires regular monitoring overseen by licensed environmental professionals

Process and Monitoring:

Place a sand layer above the sediments at the bottom of the lake to minimize dispersion or disturbance.
Fill to surface with clean material.
Quarterly monitor groundwater and report to FDEP and EPD.

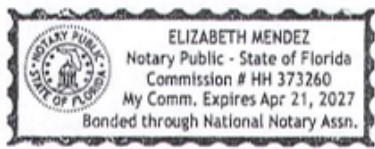

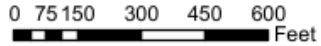
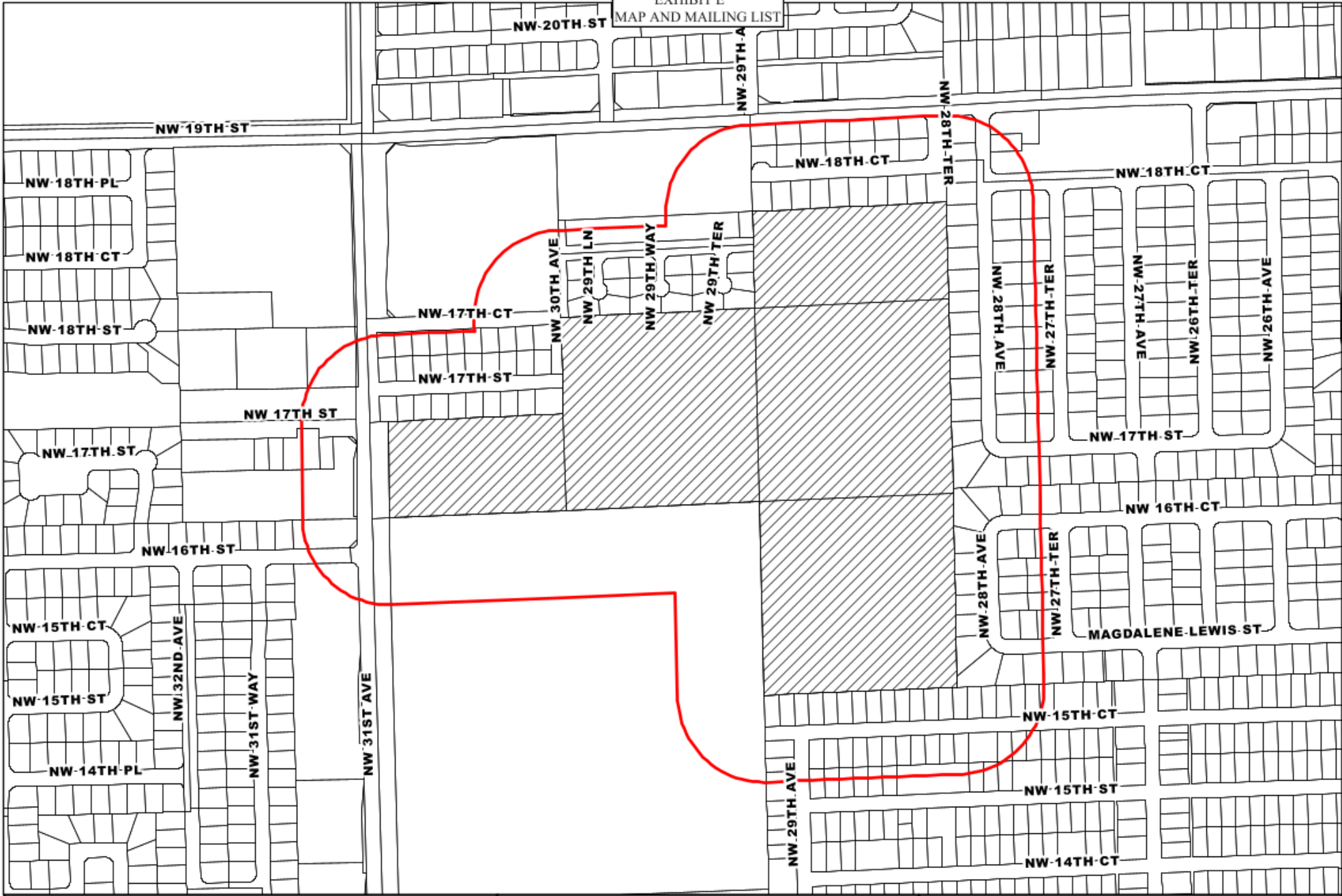
