Brief Project Summary:

This project is for the replacement of approximately 100 linear feet of seawall along Sebastian Street and Seville St west of Birch Road. Also, the proposed project improvements include the replacement of existing drainage infrastructure and milling & paving.

Both seawalls are being replaced due to their deteriorating condition and the need to comply with the City of Fort Lauderdale's new seawall height ordinance of 5.0 NAVD. The new drainage infrastructure will address tidal flooding at both of these locations. This project seawall infrastructure has been identified for replacement on the City of Fort Lauderdale's Seawall Masterplan.


