

RESOLUTION NO. 26-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A DISTRICT FOUR MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION, FOR THE INSTALLATION OF SOLAR-POWERED RECTANGULAR RAPID FLASHING BEACONS WITHIN THE RIGHT-OF-WAY OF STATE ROAD A1A/SEABREEZE BOULEVARD AND CASTILLO STREET, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale ("City") wishes to enter into a Florida Department of Transportation District Four Maintenance Memorandum of Agreement ("MMOA") with the Florida Department of Transportation ("FDOT"), for the installation of solar-powered Rectangular Rapid Flashing Beacons (RRFB) within the right-of-way of State Road A1A/Seabreeze Boulevard and Castillo Street; and

WHEREAS, because State Road A1A is an FDOT right-of-way, authorization for this work must be permitted by FDOT; and

WHEREAS, FDOT requires municipalities to maintain any features on state roadways that are beyond standard treatments, including RRFBs; and

WHEREAS, the MMOA formalizes the City's maintenance obligations, identifying the location and maintenance requirements of the improvements to be maintained by the City within FDOT right-of-way;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission of the City of Fort Lauderdale, Florida, hereby approves a District Four Maintenance Memorandum of Agreement with the Florida Department of Transportation, for the installation of solar-powered Rectangular Rapid Flashing Beacons within the right-of-way of State Road A1A/Seabreeze Boulevard and Castillo Street.

SECTION 2. That the office of the City Attorney shall review and approve as to form all documents prior to their execution.

SECTION 3. That this Resolution shall be in full force and effect upon final adoption.
