Section A

1. **Summary of the proposed ordinance, to include the public purpose to be served by the proposed ordinance, such as serving the public health, safety, morals, and welfare of the City.**

The proposed ordinance amends Chapter 15, Article X, Vacation Rentals, to clarify enforcement authority, strengthen administrative provisions, and improve compliance with the City's Vacation Rental Program. The amendments enhance the City's ability to effectively administer and enforce existing regulations, promote consistent application of the ordinance, and protect the health, safety, welfare, and quality of life of residents and visitors.

2. **Estimate of direct economic impact of the proposed ordinance on private, for-profit businesses in the City.**

- a. **Estimate of direct compliance costs that businesses may reasonably incur if the ordinance is enacted.**

Businesses operating in compliance with the City's Vacation Rental Program are not expected to incur significant additional compliance costs. Costs may be incurred only by operators who fail to comply with the ordinance or who must correct existing violations.

- b. **Identification of any new charge or fee on businesses subject to the proposed ordinance or for which businesses will be financially responsible.**

The proposed ordinance does not establish any new registration fees or administrative charges. It revises certain enforcement provisions, including civil penalties applicable to non-compliant vacation rental operators.

- c. **An estimate of the City's regulatory costs, including an estimate of revenues from any new charges or fees that will be imposed on businesses to cover such costs.**

The proposed ordinance is not anticipated to increase the City's regulatory costs and does not establish any new fees to recover regulatory expenses.

3. **Good faith estimates of the number of businesses likely to be impacted by the proposed ordinance.**

The proposed ordinance may impact all vacation rental operators subject to Chapter 15, Article X. As of May 29, 2026, the City had approximately 1,514 registered vacation rental properties.

4. **Any additional information the City may deem to be useful.**

If adopted, the ordinance will become effective thirty (30) days after adoption. During the implementation period, the City will notify registered vacation rental operators of the amendments and provide outreach to promote voluntary compliance.
