TITLE: Resolution Approving and Ratifying a Collective Bargaining Agreement Between the City of Fort Lauderdale and International Association of Firefighters AFL-CIO-CLC Representing the Battalion Chiefs Effective October 1, 2026, Through September 30, 2027, and Authorizing Execution of the Collective Bargaining Agreement - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission adopt a resolution approving and ratifying a Collective Bargaining Agreement (CBA) between the City of Fort Lauderdale and International Association of Firefighters (IAFF) AFL-CIO-CLC representing the Battalion Chiefs effective October 1, 2026, through September 30, 2027, attached as Exhibit 2.

Background

The previous IAFF CBA expires on September 30, 2026. The City and IAFF began negotiations for a successor agreement in February 2026 and met eight (8) times. Through these negotiations, the City and the IAFF came to a tentative agreement for a one (1) - year contract commencing on October 1, 2026, and expiring on September 30, 2027. The tentative agreement was presented to the IAFF membership for ratification and IAFF advised the City that the respective employees voted to ratify the agreement on August 4, 2026.

Resource Impact

The estimated FY 2027 impact of this agreement is \$308,025. Funding required to implement this contract is included in the FY 2027 Budget.
