REQUEST: * Amend City of Fort Lauderdale Unified Land Development Regulations Article VII, Notice Procedures, Section 47-27.4, Notice for site plan level I, II, III and level IV, conditional use, plats, and amendments to site plan level III and IV; Section 47-27.5, Rezoning and change in uses; Section 47-27.6, Vacation of public rights-of-way; Limiting Public Participation Presentations to No More than Six (6) Months Prior to Planning and Zoning Board Meeting.

APPLICANT: City of Fort Lauderdale

COMMISSION DISTRICT: Citywide

Mr. Hetzel recalled that at the December 2025 Planning and Zoning Board meeting, the Board had sent a communication to the City Commission which recommended augmenting Code with regard to public notices. The concern had been with public participation meetings that occur too far in advance of the actual Planning and Zoning Board hearing, which this item would address.

The Item before the Board today is a text amendment which limits how early an application may hold their public participation meeting. The window for these meetings would be changed to no more than six months prior to the Board meeting and within 30 days of some Planning and Zoning Board meetings.

At this time Chair McTigue opened the public hearing. As there were no individuals wishing to speak on the Item, the Chair closed the public hearing and brought the discussion back to the Board.

Motion made by Ms. Scott, seconded by Mr. Buckley, that we approve UDP-T26001, recommend approval, and the Board hereby finds that the text amendment to the ULDR is consistent with the Comprehensive Plan. In a roll call vote, the **motion** passed 7-0.

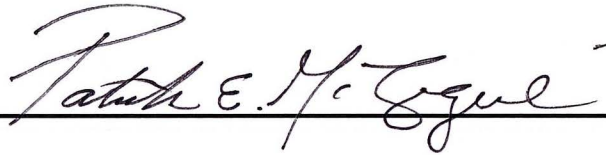

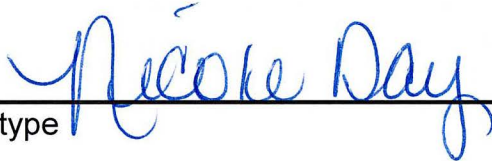
