

RESOLUTION NO. 26-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A STATE-FUNDED GRANT AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION ("FDOT") FOR THE CONSTRUCTION PHASE OF THE GALT MILE STREET SAFETY IMPROVEMENTS PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on February 1, 2025, the City Commission of the City of Fort Lauderdale ("City") adopted Resolution A-95-1 formally declaring the City's intent to undertake right-of-way improvements to and along Galt Ocean Drive, extending from East Oakland Park Boulevard to the south and the City's northern limited ("Project"); and

WHEREAS, on May 2, 2023, the City Commission approved an agreement with Chen Moore & Associates, Inc., for Design and Construction Administration Services for the Project; and

WHEREAS, on May 7, 2024, the City Commission adopted Resolution 24-83, authorizing the City Manager to execute an agreement with Florida Department of Transportation ("FDOT"), accepting the grant funding in the amount of \$500,000 for the design development phase of the Project which includes the replacement of the existing sidewalks, milling and resurfacing the existing pavement, sidewalk widening, landscape improvements, installation of street lighting, and installation of pavement markings and regulatory signage; and

WHEREAS, the City applied for \$2,500,000 in FY 2025/26 General Appropriation Act grant funding in April 2025, and in November 2025, FDOT notified the City it was awarded funding in the amount of \$500,000 for construction;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Manager is hereby authorized to execute the Florida Department of Transportation State-Funded Grant Agreement in the amount of \$500,000 for a grant for Construction Phase of the Galt Mile Street Safety Improvements Project; and

SECTION 2. That if any clause, section, or other part of this resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this resolution shall not

be affected thereby, but shall remain in full force and effect.

SECTION 3. That this Resolution shall be in full force and effect upon its adoption.
